WHO IS ELIGIBLE TO APPLY?

1. South African citizens who are permanently employed by Musina Municipality.
2. Applicants should not have previously benefitted from LGSETA learnership for the same programme.
3. Employees performing duties related to financial management
4. Employees who have enlisted the programme with their skill audit / development plan
5. Employees with a plan to venture into roles involving municipal finance management.
6. Employees committed to adhering to learnership agreement and fulfilment of all terms & conditions of the programme for the duration of the learnership including completion and submission of POE'S.

DURATION

The learnership will be for a period of 12 months depending on the applicant's area of specialisation and qualification.
