Local Authority Notice on the tabled Vhembe District and Its Local Municipalities' Drafts 2024/25 Integrated Development Plan (IDP) Review and 2024/25 - 2026/27 Budget.

In terms of section 34 of the Municipal Systems Act, 2000 (Act no.32 of 2000) and section 21 of Municipal Finance Management Act, 2003 (Act no. 56 of 2003), Municipal Council must review its Integrated Development Plan & Budget annually in accordance with an assessment of performance measurements and ensure that they are mutual consistent and credible.

The Drafts 2024/25 IDP Review and 2024/25 - 2026/27 Budget were tabled to Vhembe District and Its Local Municipalities Council for Approval. In terms of section 23 of MFMA 56 Of 2003 and section 16/21/29 of MSA 32 of 2000, Municipal Council must consult on the tabled IDP and Budget.

It is in this context that the district and its local municipalities are inviting all Traditional Leaders, Traditional healers, Business people, Council of churches, Youth council, Women groupings, Farmers, NGOs, Community members, Sector departments and other organized stakeholders and Formations to attend meetings from the 2nd to 25th of April 2024 as in table A.

All interested residents, business, structures, institutions, and sectors are hereby invited to submit written comments on the Draft IDP and Budget to the Municipal Manager within 21 days commencing from 02 April to 03 May 2024 as in table B. Copies will be available at all municipalities offices, i.e Makhado, Musina, Thulamela, Collins Chabane, Traditional councils, Thusong centres, Libraries, Local civic centres and satellites offices
